PROGRAM INFORMATION

LOCATION

All sessions will be held in the D.C. metropolitan area, provided that public health and/or weather conditions allow. Firms and companies that sponsor the Academy usually host at their offices, most of which are in the District. If we need to meet virtually, we will use the Zoom platform.

PROGRAM DATES

The incoming class kicks off with a half-day Orientation in October of the year prior to the class year, and a half-day Intro Module on Personal Brand in November. Full-day sessions take place in January (2 consecutive days), February, March, April, May, June, July and September. Fellows are expected to attend all sessions and, also, meet in smaller cohort groups between sessions to optimize learning.

TUITION

Tuition for the Class of 2023 is under review. (For the Class of 2022, tuition was \$5,250 for ACC members. The tuition fee for non-members adds on the cost of one year of ACC membership.) Tuition includes: a comprehensive 360 assessment; two professional coaching sessions; and one-year subscription to the Harvard Business Review. Limited financial aid may be available.

APPLY ONLINE

Applications will be posted on the [Academy website](#) on or about February 1, 2022. Completed applications submitted on or before March 1 will receive priority review. Applications received after March 1 will be considered on a rolling basis.

Applicants must have at least two years of in-house experience and seven years of legal practice as of September 2022. Applications require one or two letters of recommendation and three short essays.

As a Leadership Academy Fellow, you will:

- Cultivate your executive voice and presence to be an impactful business partner and advance your role within your organization and the legal community.

- Build strong professional relationships and expand your in-house network across an array of industries and organizations in the National Capital Region.

A class of approximately 30 distinguished in-house counsel – known as Fellows – will be chosen through an admissions process designed to create a well-balanced, high-caliber class. Each Fellow will also be part of a smaller cohort to facilitate learning and to support one another's professional development. The instructional sessions will span over the course of 12 months (two half-days and nine full days). Each Fellow will complete a 360 assessment process over the summer prior to the start of the Academy.

The Academy is taught by [nationally recognized faculty](#) at the top of their fields and focuses on leadership competencies essential to advancement in the in-house role, including: how to develop and lead a high performing team, decision-making, managing change and managing difficult conversations and influencing.

The [Academy Board of Advisors](#) is comprised of highly regarded, current and former General Counsel from a variety of companies and organizations across the region. Board of Advisors members interface directly with Academy faculty and participate in each session to deliver key insights and perspectives. Board members also participate in social gatherings over the course of the program.
